Guidance on Health Protocol

The well-being of participants, staff, service providers and hosts is a priority. The Ministry of Health and the District Health Office have developed rigorous protocols for a safe and successful gathering with bubble concept for participants and staff throughout the entire event where interacting with individuals outside the bubble is discouraged.

Updates on these health protocols will be made to reflect the current situation and is based on ongoing consultations with authorities and experts.

Overview

- All official venues, hotels and transport providers will apply the meeting's health protocols.
- All participants must present a verified complete COVID-19 vaccination status at a minimum of 14 days prior to the departure.
- All staff authorized to have access to the meeting's venues must also be fully vaccinated against COVID-19.
- Participants are required to show the result of 72-hours pre-departure PCR tests to pick up badge and have the access to meeting venues.
- Participants must wear masks and apply hygienic measures including handwashing with water and soap or hand sanitizer at all times.
- Participants must rigorously maintain physical distancing at all times.
- Participants need to promote their immunity level by exercising a hygienic and healthy lifestyle.
- Participants must avoid attending any event with any parties outside the bubble.
- Participants must install PeduliLindungi App in order to have access to meeting venues and accommodation.
- The (meeting name)'s Guidance on health protocols applies to the (meeting name)'s official programme.

Health Protocols

Pre-departure Preparations

Individuals who need a visa to enter Indonesia will be required to apply the followings:

- 1) Identification with nationality information (e.g., copy of passport)
- 2) Reason for the stay in Indonesia, length of stay, and accommodation details
- 3) Proof of arrival in Indonesia (e.g., ticket or accommodation booking)
- 4) Proof of insurance covering stay in Indonesia (COVID-19 coverage shall be included)

In the case of a confirmed case requiring hospitalization and other health unfortunate circumstances, participants' insurance should be covering health care costs spent in Indonesia. The necessary documents must be submitted in English.

Health measure preparation prior to departure

To ensure utmost health journey, the following are health measures to prepare prior to departure:

- 1. Verify a valid COVID-19 vaccine certificate.**
Participants must register their vaccine certificate at <http://vaksinln.dto.kemkes.go.id/> prior to departure to Indonesia. Information of vaccination (e.g. vaccination certificate with details of the holder, administered vaccines, the institution that performed the vaccination, date of complete vaccination (either a single or a double dose of a complete primary series depending on the vaccine platform) will be required and of which should prove that complete vaccination had taken place at a minimum 14 days prior to arrival. It is highly recommended that this registration be completed 15 days prior to departure.
- 2. Perform COVID-19 PCR 72 hours prior to the departure.**
Participants will need to present a valid negative COVID-19 PCR test result taken 72 hours prior to the departure at the airport.
- 3. Install PeduliLindungi tracing application and register in electronic Health Alert Card (eHAC).**
Upon verifying the vaccine certificate through <http://vaksinln.dto.kemkes.go.id/> information regarding vaccination history and COVID-19 test result will be accessible at PeduliLindungi app.

Arriving Indonesia

On-arrival COVID-19 testing and document confirmation

Upon landing in Indonesia, all participants will have to present the following:

1) Electronic Health Card (e-HAC) and COVID-19 vaccine certificate

Delegates must update their most recent health condition upon entering Indonesia by filling out the e-Hac menu at the PeduliLindungi app.

2) Negative PCR test result 72-hour prior departure

Participants will present a valid negative COVID-19 PCR test result taken 72-hours ahead of departure upon arriving in Indonesia. Health procedures will be performed at the airport, including body temperature check and COVID-19 PCR test examination (entry test).

The result will be directly connected to the PeduliLindungi App. Upon the examination no further follow-up from participants or their staff as the PeduliLindungi App will have this information documented.

Entering the Meeting

To receive a badge to access the meeting, all participants must have their PeduliLindungi App ready and scan the QR code made available at the venues. There will be no requirement to show any paper documents regarding a test result or vaccine certificate as the PeduliLindungi App will have this information documented.

During the Meeting

During the week of the (meeting name), Rapid Antigen tests will be performed daily to all delegates before entering the meeting. Tests are available for free at the hotel, and results are normally processed within 10 minutes. The test and its results are automatically connected to PeduliLindungi App, and no further follow-up from participants is required.

Leaving Indonesia

It is the current practice applied by many countries that prior to leaving Indonesia, travelers are required to take a 72-hour test ahead of traveling.

Pre-departure testing availability

Participants may take a PCR test made available at the hotel and use the results of their 72-hour test ahead of travel in case required for their travel outside of Indonesia. Testing is free for all participants.

Bubble Meeting and Accommodation

The (meeting name) will apply a rigorous bubble concept, ensuring participants' exclusive engagement is limited to vaccinated and negative tested individuals. Entry to bubble meetings and accommodations is limited to participants and selected staff holders of a valid Verification Card and badge.

All participants and staff are required to scan a QR code with the PeduliLindungi application before entering any meeting venue and hotel accommodation. There will be advanced sanitation measures, enhanced ventilation, adaptations to food and beverage provision, interaction and hygiene measures, and an expansion of the spaces available within this bubble.

Participating in or organizing any third-party activities – not associated with the (meeting name) or outside the official venues – is discouraged in the interest of collective safety.

Interaction and hygiene

The combination of vaccinations and regular testing allows the bubble meeting to be conducted effectively.

Additional measures are in place which include:

- Enhanced pandemic protocols will be put in place for all service, media, and technical staff inside the bubble meeting and accommodations.
- All areas will be cleaned and disinfected several times a day inside the bubble meeting and accommodation. Additional state-of-the-art ventilation systems are installed in areas with restricted air circulation.
- Meeting room capacity will be capped and physical distancing markers will be present where needed.
- Wearing masks is mandatory at all times and should be changed regularly throughout the day. Masks will be widely available throughout the (meeting name) bubble hotels.

- Collective adherence to behavioural and hygiene principles for the full duration of the meeting and at all locations will further enhance safety:
- Avoid physical contact, including hugs and handshakes.
- Wash your hands regularly. Hand sanitizer dispensers will be widely available at the meeting venues.
- If you need to cough or sneeze, please do so into your mask or tissue, and wash your hands afterward.
- Masks are required in all public areas of hotels, restaurants, and meeting venues. Restaurants of the meeting and hotel accommodation follow health protocol standards. All staff handling food and beverage must wear masks and gloves at all times.

Transportation

On all official meeting transportation, all passengers and drivers will be required to wear masks. Vehicle providers are obliged to ensure drivers are fully vaccinated, tested negative Rapid Antigen tests, disinfect vehicles after each transfer and exercise additional sanitization every 24 hours.

Participant activities

Adherence to health protocols is essential to prevent the spread of COVID-19. All participants are expected to follow the guidance on health protocol at hotels and meeting venues before exiting the bubble.

All participants are required to take a PCR test to exit the bubble.

Management of COVID-19 positive cases and close contacts

In case of a rapid antigen test positive result, individuals will be retested with a PCR test for further confirmation.

If the PCR test remains positive, participants must remain isolated at their accommodation or, if necessary, undertake hospitalization at their own insurance term.

Individuals will need to remain isolated at their accommodation upon receiving a positive test result. Isolation is mandatory until the local authorities contact the individual.

The medical station and emergency team is available at the venues. If necessary, ambulance teams are available to refer delegates to appointed hospitals to obtain proper medical treatment.
